Now as in the first case the charterer of the American Mercantile Company is shown to be neither a holder of a charter party nor a holder of a bill of lading nor a holder of a cargo, for the simple reason that it did not execute the contract to hire the ship, and could not be injured by any failure of the shipowner to observe a verbal contract. As to the second part, if it is the owner of the ship, the part owner is injured by the injury to the charterer as to the second part in the recovery of the value of the freight. And if it is the charterer of the ship, the injured party is the owner of the ship, and the injured party is entitled to remuneration from the owner of the ship. 4. If a charterer of a ship accepts a charter party (contract of affreightment) without the consent of his employer it is his duty to take the risk of any damage resulting from a breach of the contract. He is a party to the contract, and his damages are in the event of a breach the same as those of a party to the contract who breaches a contract. This is because he would not be allowed to recover his damages from the shipowner, if he accepted the contract of affreightment without the consent of his employer. The charterer of the American Mercantile Company is therefore entitled to recover the full amount of his damages from the vessel. The shipowner could not be allowed to plead an estoppel to an action on the contract of affreightment, as it did not represent himself to be acting as the agent of the charterer of the ship. Nor could the charterer of the ship rely on the promise of the vessel, as its agent, to transport the goods of the charterer on the American Mercantile Company's behalf.
